Our mission is to offer medical services focused primarily on quality time and attention, comprehensive examinations and immediate response," states Mark Price, CEO and co-founder of **My Home Doctor**. "At a time when doctors are overwhelmed with excessive patient loads and ERs are at over capacity, **My Home Doctor** is a convenient alternative — patients can receive expert, non-rushed treatment in the comfort of their home, office or hotel room."

In addition to providing same-day treatment, **My Home Doctor** physicians call patients one day after their consultation to follow-up. The medical team can also be reached by phone up to 48 hours after the patient has been treated. If within 48 hours of the visit the patient is still not feeling well and a follow up visit is required, **My Home Doctor** will return to the patient's home, office or hotel for a follow up consultation at no additional charge. If necessary, the physician can also make personal arrangements at a hospital, or even accompany a patient to a hospital.
